

Executive Summary of Bid Evaluation Report

Project Title: UPGRADING WORKS AT REMY OLLIER ROAD AT LA GAULETTE IN CONSTITUENCY NO. 14

Project ref: (NDU/2021/175)

(MINI-COMPETITION UNDER CONTRACT CPB/05/2020)

1. Scope of Works:

The project title is: *Upgrading works at Remy Ollier Road at La Gaulette in Constituency no. 14.*

A mini-competition was launched under the Framework Agreement for the Construction and Upgrading of Roads and Associated works on 01 September 2021.

The scope of works includes resurfacing works, laying of kerbs and cleaning of drains.

2. Procurement method used: Mini-competition

3. Date of Invitation of Bids:

Quotations for the above project were invited from Seven (7) Bidders as per Table 1 on 01 September 2021. A pre-bid meeting which was followed by a site visit was carried out on 07 September 2021 at 13h00. (Venue-SSS La Gaulette) The revised closing date for the submission of quotations was 23 September 2021.

As shown in the table, the price quoted by Bidder 3, 4 and 5 are above 15% of the cost estimate and thus pursuant to *section 2.1.1 of the Evaluation Guide of PPO*, proposals from these Bidders are considered to be on the high side and are therefore not retained for further evaluation.

9. Check for aggregate value of Work Orders with 50% of average annual turnover

The turnover limit for Bidder 1, 2, 6 and 7 were verified. It was found that although Bidder 7 (Super Builders Co. Ltd) is the lowest responsive bid, this Bidder is not eligible to be awarded new works order under the Framework Agreement of Roads (CPB/05/2020), because the value of works awarded to this bidder has neared its maximum limit with the remaining balance of Rs 3,693,725.31 on the date of submission of the BEC report.

10. Verification of Rates of Bidders' Proposals against Rates in Framework Agreement

Some rates namely for item 31, 28, 49, 54, 44 and 55 have been quoted higher than the Framework Agreement rates. Hence these rates have to be considered for payment purposes. The updated contract value is Rs 37,000,361.97, which is 7.5% lower than the cost estimate.

11. Lowest Evaluated Substantially Responsive Bid:

Bidder 1, *General Construction Company Limited* has submitted the lowest evaluated substantially responsive bid for the project the project “*Upgrading works at Remy Ollier Road at La Gaulette in Constituency no. 14*” for a revised bid amount of **Rs 37,000,361.97** inclusive of Contingencies and VAT @ 15%.
