

Executive Summary of Bid Evaluation Report

Project Title: Construction of Mini-Soccer Pitch and Lighting Facilities at Sir Guy Rozemont Stadium, Quatre Bornes

1. Scope of Works:

The location of the Works is at Sir Guy Rozemont Stadium in Quatres Bornes in Constituency No. 18.

The works will consist amongst others of the following:

- Construction of a mini soccer pitch, complete with marking;
- Construction of infiltration trenches as drainage facilities;
- Laying of fill material and construction of retaining walls to provide a platform for the proposed mini soccer pitch;
- Construction of new concrete bases for light poles;
- Installation of new 12m and 18m light poles including civil work, cabling and meter cubicle; and
- Plot levelling/grassing.

2. Procurement method used: Open National Bidding

3. Date of Invitation of Bids:

A bid exercise on Open National Bidding basis was published through the e-procurement system on 13 April 2022.

5. Date and place of opening of bids:

The deadline for the e-bidding document was for 16 May 2022 at 13 31 hours at the Ministry of National Infrastructure and Community Development (National Development Unit), Level 11, Citadelle Mall, Corners Louis Pasteur, Sir Virgil Naz and Dr Eugène Laurent Streets, Port Louis.

Opening of e-bidding document was on 18 May 2022 at 15 31 hours.
