

# **Executive Summary of Bid Evaluation Report**

## **Drain Projects in Rodrigues – Camp Du Roi Site**

**CPB Reference No. CPB/B/NDU/CROIS/02/19**

### **1. Scope of Contract**

The project consists of the following:

- Demolition of existing bridge structure and construction of new reinforced concrete bridge of 15m span and height 1.5m;
- Raising of retaining wall on both sides on upstream of river;
- Gabion protection works upstream of bridge;
- Provision of footpath and other road infrastructure;
- Provision for services ducts for any future services;
- Geotechnical investigation;
- Piling works;
- Demolition of existing roadside drains and construction of new 1.0m by 0.7m reinforced concrete covered cum footpath drains;
- Construction of twin 1.5m by 1.0m box culvert across the lateral road;
- Construction of twin 1m by 0.7m box culvert across the main road;
- Construction of “energy dissipating” structures or baffle blocks;
- Construction of 500mm by 500mm reinforced concrete drains over an approx. distance of 190m;
- Construction of approx. 40m open trapezoidal masonry drain, 500mm deep;
- Provision for necessary drainage catch pits, gratings, thrash racks etc; and
- Construction of approximately 50m concrete footpath along main road.

2. The estimated cost of the project is **Rs 53,918,037.50, inclusive of VAT.**
3. Funding Agency is the Government of Mauritius.
4. Procurement method was through Open Advertised Bidding in local newspapers.
5. Bids were launched on **30 November 2018** in local press.
6. The closing date for submission of bids was **10 January 2019** at 13 30 hours local time at the **Prime Minister’s Office (National Development Unit)**, Level 11, Cnr Louis Pasteur, Sir Virgil Naz & Dr Eugene Laurent Streets, Port Louis.
7. The opening of bids was held on **10 January 2019** at 13 45 hours in the Conference Room of the Prime Minister’s Office (National Development Unit), Level 11, Cnr Louis Pasteur, Sir Virgil Naz & Dr Eugene Laurent Streets, Port Louis.

8. Two (2) bids were received by the closing date and time mentioned above.
9. One addendum was issued.
10. The bids are to be valid for 90 days and bidders were required to submit a Bid Securing Declaration.
