- Construction of drain at Begonia Avenue, Rajkumar Lane, La Source
- Construction of drain at Lane Off-Louvet Avenue
- Construction of drain at Avenue Jaylall, Palma (Extension of drain in Dookhee Lane)
- Construction of drain at off Impasse Ollier near Pharmacy Cambridge
- Construction of drain at Gooly Lane

Procurement method used:

The method of procurement is Open National Bidding (ONB). All submission of Bids were made through the Government of Mauritius E-Procurement System.

7. Conclusion & Recommendation

The lowest substantially responsive bid is from Bidder 3 – Monesh Enterprises Ltd for the corrected amount of Rs 23,606,055.00 (exc. Vat). This bid amount is 14.16% lower than the cost estimate of Rs 27,500,000.00 exc. Vat) and is within the allowable threshold of 15%.

It is therefore, recommended that **Bidder 3 – Monesh Enterprises Ltd** be considered for the award of the contract “**Drainworks in Constituency No. 18**” for the corrected bid amount of **Rs 23,606,055 (exc. Vat)**.
